**DETERMINATION OF NONSIGNIFICANCE**

Pursuant to Chapter 463-47 WAC and WAC 197-11-340

**CHEHALIS GENERATION FACILITY**

**REQUEST TO TRANSFER THE SITE CERTIFICATION AGREEMENT  
TO PACIFICORP**

**Description of current proposal:** Chehalis Power Generating LLC (Chehalis Power) is selling the certified Chehalis Generation Facility (Project) to PacifiCorp. Chehalis Power and PacifiCorp have jointly applied to EFSEC to transfer the Site Certification Agreement for the Chehalis Generation Facility to PacifiCorp.

There will be no change to the Project operation or to Site Certification Agreement conditions. If approved and once the ownership and the Site Certification Agreement are transferred, PacifiCorp will be authorized to operate the Project.

**Address and location of proposal:** The Chehalis Generation Facility is located at 1813 Bishop Road, Chehalis, WA 98532.

**Titles of documents that have been previously adopted:** In 2000 the lead agency compiled and adopted an addendum to Environmental Impact Statement (EIS) prepared by the Bonneville Power Administration (BPA) for the Resource Contingency Program (of which the Project was a part) and other related National Environmental Policy Act (NEPA) documents adopted by EFSEC in 1996.
