ORDER TERMINATING  
APPLICATION NO. 81-1

THIS MATTER came on regularly before the Energy Facility Site Evaluation Council (hereafter called Council) at its regular meeting of December 12, 1983. Puget Sound Power and Light Co., (hereafter called Applicant) notified the Council by letter dated November 23, 1983 of the desire to withdraw their application.


The Council has considered this matter at its regular meetings of January 9, 1984 and January 23, 1984 and has determined that further application processing should terminate provided, that work on the Nuclear Regulatory Commission/Energy Facility Site Evaluation Council (NUREG) report, "State/Federal Cooperation in the Licensing of a Nuclear Power Plant" shall be pursued to completion.

The Council has also determined that records management activities and financial reconciliation be completed by March 31, 1984, and that dismissal should be effective as of that date.


NOW, THEREFORE, BE IT HEREBY ORDERED that project evaluation of Application No. 81-1 will cease on January 31, 1984; that the NUREG report associated with the project will be completed; that appropriate closeout actions will be taken regarding records management and financial reconciliation; that all activity associated with Application No. 81-1 shall be terminated on March 31, 1984 and that the application shall be dismissed March 31, 1984.
