ORDER ON
PREHEARING CONFERENCE

THESE MATTERS Having come on regularly before Patrick Biggs, Administrative Law Judge for the Energy Facility Site Evaluation Council at a pre-hearing conference held on Monday, May 11, 1981, which conference was held pursuant to notice duly given and was attended by several parties and intervenors, where these matters were discussed and arguments of all sides were considered;

NOW, THEREFORE, THE FOLLOWING ORDERS ARE MADE:

1. The next prehearing conference will be held on Monday, June 1, 1981, at the EFSEC offices in Olympia. An agenda and notice will be published in the near future. Agenda items should be submitted now. Positions of the parties and intervenors will be taken on the subject of participation in the contested case with reference to the table of contents in the application. Positions not stated at the conference on June 1 will be submitted in writing by that date.

2. The applicant will file and serve, no later than July 31, 1981, a supplement to its application, adding environmental data relating to the Southern corridor option for routing transmission lines. The applicant is encouraged to designate the actual route chosen for this line at the earliest possible time.

3. Pre-filed testimony, in a form to be the subject of a later order, will be filed by the

applicant no later than July 31, 1981. This testimony will be designed to support each and every request made in the application. Objections to the admissibility of any evidence will be made in writing no later than Monday, August 24, 1981. Replies to the objections will be submitted in writing no later than Monday, September 7, 1981.

4. The parties and intervenors will serve and file requests for the location and subject matter of hearings held away from Olympia. These requests will be submitted no later than August 3, 1981.


