

**WASHINGTON STATE

**RESOLUTION 280**

WHEREAS, The Energy Facility Site Evaluation Council (Council) has adopted rules directing applicants and certificate holders to formulate plans for site restoration, effective March 11, 1987; and

WHEREAS, The Washington Public Power Supply System (Supply System) is a certificate holder and subject to the Council's rules regarding site restoration; and

WHEREAS, The Supply System has terminated its plans to complete Nuclear Projects WNP-1, 3, 4, and 5; and

WHEREAS, The Supply System on March 8, 1995 submitted a Site Restoration Plan for Nuclear Projects 1, 3, 4, and 5 in compliance with WAC 463-42-665; and

WHEREAS, The Council has conducted a review of the plan with the assistance of state agencies; and

WHEREAS, The Council has provided the public an opportunity to comment on the plan during public meetings held May 11 in Montesano and May 18, 1995 in Richland; and

WHEREAS, The Council has considered the environmental effects of site restoration and has made a State Environmental Policy Act (SEPA) Determination of Nonsignificance; and

WHEREAS, The Council has determined that the plan contains the conceptual elements necessary for the protection of public health, safety, and the environment; and

WHEREAS, The Council recognizes the actual demolition/restoration methods have not been determined at this time and that specific details of the plan may require additional Council review and approval before and during demolition/restoration activities; and

WHEREAS, The Council further recognizes that funding arrangements for restoration have not been fully resolved and that changes in the restoration plan may be necessary in view of financial considerations; and

WHEREAS, The Council recognizes that adoption of this Resolution approving the Supply System's current Site Restoration Plan will supersede all previous site restoration plans and commitments and will close EFSEC Resolutions Nos. 243, 245, and 246.

NOW, THEREFORE, BE IT RESOLVED, That the Energy Facility Site Evaluation Council hereby approves the Supply System's Site Restoration Plan, dated March 8, 1995, for Nuclear Projects WNP-1, 3, 4, and 5; subject to the commitments therein and Council rules.

BE IT FURTHER RESOLVED, That the Supply System shall submit specific details of site restoration, consistent with the conceptual plan, as soon as those details are determined, for Council review; and that changes in the scope, timing and/or level of the restoration effort shall be treated as an amendment to the restoration plan and be subject to full review and approval by the Council.
