

DETERMINATION OF NONSIGNIFICANCE AND ADOPTION OF EXISTING ENVIRONMENTAL DOCUMENTS

Description of current proposal The Energy Facility Site Evaluation Council (EFSEC) proposes to adopt by reference five recent Ecology rule revisions into Chapter 463-78 WAC to assure consistency with Ecology's rules, as directed in RCW 70.94.422. EFSEC proposes to adopt by reference three recent Ecology rule revisions to Chapter 173-400 WAC and two recent Ecology rule revisions to Chapter 173-401 WAC. EFSEC proposes to adopt the environmental checklists issued by Ecology for two of its rule revisions. EFSEC will issue its own DNS.
