

**SUMAS ENERGY 2 ADJUDICATORY HEARING
PRELIMINARY ISSUE & WITNESS ORDER
July 17, 2000**

The following order generally lists witnesses only once. Margaret Curtis has submitted different testimony on behalf of different parties, so she is scheduled to appear in connection with each separately. With the exception of Ms. Curtis, all of each witness' testimony will be presented during his/her one appearance, even if the testimony covers many different topics.

For witnesses who have addressed multiple topics, (in most cases) each witness is scheduled to appear in connection with the first of his/her topics. There were, however, two witnesses that it seemed to make more sense to schedule in connection with a subsequent issue they addressed: Eric Hansen with noise, rather than view; and Nancy Hirsh with greenhouse gases rather than transmission constraints. SE2 and NVEC have consented to this arrangement.

SE2 witnesses who are both direct and rebuttal witnesses are scheduled to take the stand once, in the direct witness slot, and to be cross-examined on both their direct and rebuttal prefiled testimony at that time. SE2 reserves the right to recall them, if necessary, to rebut live testimony provided by intervenor witnesses during cross-examination. SE2 hopes that will not typically be necessary.

The total number of minutes estimated for cross-examination is indicated in bold italics type following each witness' name and affiliation. This total is taken from the email circulated by Mary Barrett. The parties reserve the right to object to cross-examination that is "friendly" or outside the scope a party's intervention.

PLEASE NOTE: This proposed order does not take into account scheduling conflicts of individual witnesses.
