1 Whistling Ridge Energy LLC on March 10, 2009 filed with the Washington Energy Facility Site Evaluation Council (Council) an application for certification of a site in Skamania County, Washington for construction and operation of an energy facility producing power through use of wind energy.

2 On June 24, 2009, the Council issued a notice to all interested persons of the opportunity to intervene in the proceeding. A prehearing conference was held in Olympia, Washington on July 28, 2009 for the purpose of ruling upon petitions for intervention. All petitions for intervention were allowed, including a subsequent late-filed petition.

3 Procedural aspects of the adjudication have been deferred pending preparation of environmental studies. A prehearing conference is appropriate to review the status of such studies and to develop a schedule for the adjudicative proceeding.

4 **THE COUNCIL GIVES NOTICE that it will hold a prehearing conference in this matter at 1:30 p.m., on June 17, 2010, in Conference Room – Stevenson B, Skamania Lodge, 1131 SW Skamania Lodge Way; Stevenson, Washington.**

5 The purpose of the prehearing conference is to consider the status of preparation for the proceeding, the timing of filing parties’ direct evidence, the procedural steps that will be appropriate in this matter and the timing of such steps, to resolve scheduling matters including dates for distributing evidence, to begin the identification of issues in the proceeding and determine other matters to assist the Council in resolving the matter. This may involve consideration of the following elements:

Call to order

Appearances by parties of record

Consideration of hearing procedure, which may include the following elements:

1. Consideration of use of prefiled testimony and exhibits
2. Discussion of schedule for hearing elements
 - a. Identification of issues

- b. Discovery, if any
 - c. Motion practice and schedule
 - d. Status conferences
 - e. Site visit, if appropriate
 - f. Prefiling schedule for responsive and rebuttal testimony
 - g. Order of parties' presentations
 - h. Numbering of exhibits
 - i. Scheduling of witnesses
 - j. Hearing schedule and location
 - k. Timing and content of Post-hearing submissions, including draft order and site certification agreement
 - l. Other items relating to procedure at the hearing
3. Other matters proposed by parties. Parties that have specific suggestions for consideration on the items above, or that would propose other items for consideration, should provide basic information about each proposal to the Council and other parties, to be received no later than Monday, June 14, 2010.

6 **THE COUNCIL GIVES NOTICE that any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440.**
