PREHEARING CONFERENCE
ORDER No. 2

684

This is an application for certification of a proposed site at Chehalis, Lewis County, Washington for construction and operation of a natural gas-fueled combustion turbine facility to generate electrical energy.

The Council held a prehearing conference on July 25, 1995, before Council Chair Frederick S. Adair and members C. Robert Wallis, Ron Skinnarland, Terry Strong and John Nacht.

APPEARANCES. The following parties participated in the prehearing conference: Applicant, Chehalis Power Inc., by Elizabeth Thomas, attorney, Seattle; Counsel for the Environment, by John Sampson, assistant attorney general, Olympia for Thomas Young; assistant attorney general, Olympia; Critical Issues Council, Allen T. Miller, attorney, Olympia; Department of Ecology, by Mary Sue Wilson and Ronald L. Lavigne, assistant attorneys general; and Washington State Energy Office, by Tommy Prud'Homme, assistant attorney general, Olympia.

In this order, the Council discusses scheduling matters and other administrative issues.

Issues List. The parties agreed that the final consolidated list of issues would be completed and presented to the Council by August 25, 1995.

Site Visit. The parties agreed that the Applicant would make arrangements for Council Members, Council Staff, and one person representing each intervenor party to view the site of the proposed facility on September 7, 1995. The Applicant agreed to provide transportation by bus to and from the site. The bus will leave from Washington State Energy Office parking lot at 9:30 a.m. Questions regarding the site visit can be addressed to Allen Fiksdal, Siting Specialist, EFSEC, P.O. Box 43172, Olympia, WA 98504-3172, or Mr. Fiksdal can be contacted by phone at (206) 956-2162.

Next prehearing conference. The parties agreed to reserve September 7, 1995, at 1:00 p.m., for a continued prehearing conference. If, however, the site visit scheduled for the same day is not completed by the 1:00 p.m., the prehearing conference will commence one hour after the parties return from the site visit. The conference will take place in Room 308 of the Washington State Energy Office.

Motion to Exclude Issues. The Council will make its determination on the Applicant's motion to exclude issues from the adjudication as soon as possible. However, if the Council has not issued its decision by August 4, 1995, intervenor parties' prefiled testimony will not be due until 10 days after the date the Council enters its order

Prefiled Testimony. The intervenor parties' prefiled testimony is due either on August 14, 1995, as previously scheduled, or ten days after the date the Council enters an order regarding the Applicant's motion to exclude issues, whichever is later.

Stipulations. The Applicant advised the Council that it has reached preliminary stipulated agreements with several parties. The Applicant agreed to submit such stipulations to the Council when finalized.


