Notice is hereby given that the above-captioned Appellants appeal that land use decision of Respondent entitled Skamania County Resolution 2009-54 (Certification of Land Use Consistency Review for the Amended Application for the Whistling Ridge Energy Project). The Decision reviews the Whistling Ridge Energy Project ("Project") and finds the Project "consistent with the Skamania County land use plans and applicable zoning ordinances."

The Decision became final on December 22, 2009. Appellants first learned of the Decision seventeen days later, on January 8, 2010. Appellants first received a copy of the Staff Report for the Decision on January 21, 2010.

This Appeal is limited only to the portions of the Project proposed within the General Management Area of the Columbia River Gorge National Scenic Area, and the County's erroneous

conclusion that these portions of the Project are consistent with, and allowed pursuant to, the County Scenic Area ordinance. The County erroneously determined that the portions of the Project proposed within the General Management Area are allowed, despite the Project's industrial nature. The Project is an industrial use and is strictly prohibited within the General Management Area. In addition, Respondent failed to provide proper notice of its action.

<u>ADR Statement</u>: Appellants are willing to attempt to resolve the appeal through mediation or other alternative dispute resolution.

Shortened Record: Appellants are not willing to consider a shortened record.
