Application No. 2013-01 ORDER DENYING MOTIONS CONCERNING FACILITIES AND TESORO SAVAGE, LLC **SCHEDULE** VANCOUVER ENERGY DISTRIBUTION **TERMINAL** On June 3, 2016, Tesoro Savage LLC (Tesoro-Savage) filed Applicant and Port of Vancouver USA's Joint Motion Concerning Facilities and Schedule. On June 3, 2016, Columbia Riverkeeper, et al. filed Columbia Riverkeeper et al. Motion Concerning Facilities and Schedule, and the City of Vancouver filed City of Vancouver's Response to Motion Concerning Facilities and Schedule. Among other requests, the moving parties ask the Administrative Law Judge (ALJ) to issue an order that: 1. Assures Wi-Fi connection capacity during the adjudication; 2. Requires the hearing facilities to provide caucus room space; 3. Requires the hearing facilities to provide computer connectivity that will allow an alternate means of showing video or projection of exhibits; 4. Assures cell phone connectivity in the hearing and caucus rooms; 5. Requires the hearing facilities to provide tables and a minimum of 20 dedicated electrical outlets for the exclusive use of Tesoro-Savage and the Port and 7 more for Columbia Riverkeeper, et al. and Columbia Waterfront; 6. Requires the facilities to provide tables of a certain size; and 7. Requires the hearing facilities to provide early access to the hearing rooms. The ALJ's powers do not extend to jurisdiction over cell phone companies, Clark College or the Red Lion Hotel. These are appropriately matters for the parties to resolve by directly contacting the various entities. EFSEC staff can provide contact information as needed, and help parties in their preparations for the upcoming adjudication hearing, but cannot do the parties' jobs for them. Pre-Hearing Conference Request Without following the established procedure for scheduling pre-hearing conferences, the moving parties have determined that a conference will take place with the ALJ on June 24,

2016, a date when the ALJ is not available. The stated purpose of the requested conference is

"facilitation of pre-hearing matters." The parties have already been informed that they are

EFSEC and facility staff will be present on that day to assist the parties, but the parties are encouraged to contact the facilities ahead of time to ask specific facility capability questions. A formal pre-hearing conference is not necessary for these purposes on June 24, 2016.

As previously ordered, the adjudication hearing commences on the record the morning of Monday June 27, 2016 at 9:00 a.m., and Tesoro-Savage has asked that testimony "begin in earnest" at that time. To that end, the record will be opened at 8:00 a.m. on June 27, 2016 to admit agreed exhibits and bring up any other pre-hearing matters can be addressed prior to testimony. At that time, the parties should be prepared to put their arguments on the record concerning any testimony or exhibits that the ALJ has excluded.

Site Visit

The City of Vancouver has asked that a site visit be planned for the Council that does not include the attorneys, presumably out of concern that the attorneys will be presenting some argument or communication during the visit. However, any such communication would not be on the record, and will not be allowed.

The Council appreciates the cooperation that Port staff has already afforded EFSEC staff in arranging the details of the site visit. These arrangements are already ongoing and will continue. Tesoro-Savage and the Port present a suggested agenda and viewing points for the Council. However, the Council will exercise its authority to view whatever it deems necessary in the course of the site visit, and allowing for any logistical constraints that may exist at the Port. As the parties have already been informed, their attorneys will be allowed to view the same things the Council views, but substantive communications will not take place. An order dictating the conditions of the Council's site visit is unnecessary.

Public Adjudication Comment Procedures

As previously communicated to the parties, the adjudication-related public comment period will be the afternoon of Friday, July 29, 2016, after the adjudication record has been closed, except for the post-hearing briefing. At this time, it is not possible to determine the rules of participation for the public comment because it is unknown how many participants there will be. All comments will be restricted to the evidence that has been admitted in the adjudication. The Council will not accept written comments.

Exhibits

The Pre-Hearing Order Establishing Procedures and Setting Deadlines for Submittals issued on May 5, 2015 details the procedures for exhibits. It states as follows: "Proposed exhibits shall be submitted in the same way as other documents."

On the first day of the hearing, all admitted exhibits will be posted in their electronic form to the Council and ALJ so that they will be available during testimony. As exhibits are

1 2	referenced in the hearing, EFSEC staff will project them onto a screen visible to all participants.
