Here are our concerns: My husband and three or more other of our next door neighbors were never informed of any of these panel meetings of which started last May 2017 from what I understand were taking place being these said panels are going to butt up against our property in our back yard which we will have to look at out our kitchen and dinning room windows we are very concerned we were not included to attend the meetings so we could voice our concerns and learn more about this action. We were later informed after the fact that there was going to be solar panels many of them in the property behind us South of the Bull Ditch which was concerning but we could live with that but as of late we are now informed the solar panels well be added North of the Bull ditch which brings them right up to our fence line this is a real concern to all of us! We have many questions especially how this could even happen being it is zoned prime farm land here and how the property directly behind us now is zoned commercial just for this project ? We bought our property here in 1993 for the beautiful all around view we put our house and all kinds of beautiful trees and landscaped it from once that was a pasture and now we are suppose to look at solar panels? How is this going to affect our property values now? How does it affect the our animals like horses, cats, dogs and the birds? Is there sounds that we do not hear but will hurt our animals hearing? Is the panels moving around looking to follow the sun reflect blinding lights into our house? Is there a humming sound or any kind of sound coming from the panels themselves? Is there radiation of some kind coming from the panels that may affect our health or the health of our animals? Is the fencing going around these panels and the shrubbry or trees going to be like a solid wall? Is there going to be lighting all the area involved? Will the lighting around that will blind us in the evenings? We neighbors here are very concerned as we very well should be as it does involve us all.

We are a retired couple that put a invested interest in our property a number of years ago hopeing to get a return of profit in the near future but with these numerous solar panels right in our back yard we are worried the property value of our investment our home and property will deminish all that we have worked for will have gone by the way side. If you had a choice of buying a piece of property with a 360 degree beautiful view or one with a view of solid solar panels which property would you buy? So having these solar panels right in my backyard will not decrease my property value? What is the setback for private property, ditches an public roads is it really feasable to add this small portion of land and put solar panels on it and ruin the view for us an our neighbors? Our main concern is the recently added on property of solar panels north of the Bull Ditch butting up against our land and neighbors properties! Said property was added on as we understand and is a main concern to all of us involved. Please take this into concideration when adding the additonal panels. Again we and our neighbors involved did not get the opportunity to attend any meetings at all being we were not included this was wrong! You want more solar panels tear down the old barn south of the Bull Ditch that is on the property that is not in use. How do we get a copy of our concerns to the State panel that will approve or disaprove of this project? Thank you
