<p>Exit signs shall be illuminated at all times. To ensure continued illumination for a duration of not less than 90 minutes in case of primary power loss, the sign illumination means shall be connected to an emergency power system provided from storage batteries, unit equipment or an on-site generator. The installation of the emergency power system shall be in accordance with Section 604.</p> <p>Exception:</p> <ol style="list-style-type: none"> Approved exit sign illumination means that provide continuous illumination independent of external power sources for a duration of not less than 90 minutes, in case of primary power loss, are not required to be connected to an emergency electrical system. Group I-2 Condition 2 exit sign illumination shall not be provided by unit equipment battery only. <p>(IFC 1013.6.3 2015)</p> <p>Electrically powered, self-luminous and photoluminescent exit signs shall be listed and labeled in accordance with UL 924 and shall be installed in accordance with the manufacturer's instructions and Chapter 27 of the International Building Code. Exit signs shall be illuminated at all times.</p> <p>(IFC 1013.5 2015)</p>	<p>The internally illuminated exit signs in building 27 had no indication of being supplied by battery back-up or generator power. *CR 375396 has been written. Item requires 6 months to fit into the procurement and work control process.</p>

Records shall be made available for inspection by the fire code official, and a copy of the records shall be provided to the fire code official upon request.</p> <p>(IFC 107.3)</p>	<p>The facility is unable to provide records of 3rd quarter sprinkler inspections of the Protected Area.</p> <p>*Requires procedure and a frequency change in process for PPM-15.1.23. AR-SMS 376466 will change the frequency to 6 months (per NFPA 25 5.3.2.2). This item requires 6 months to complete to fit into the work control process.</p> <p>Annual Automatic Fire Alarm System annual(s) completed 10/10/2017.</p>


