If approved, The Oil terminal will become the image by which the City of Vancouver is identified. Look at Oregon City in Oregon -the paper mill identified the city and once the paper mill left, the downtown area has struggled.

Even closer to home is Longview, where Longview Fibre was the major employer and where now "The median income for a household in the city is \$35,171, and the median income for a family is \$43,869. Males have a median income of \$38,972 versus \$26,625 for females. The per capita income for the city is \$18,559. 16.7% of the population and 12.3% of families are below the poverty line."

I don't think the above is the vision anyone sees for Vancouver.

Diversification is key to Vancouver's continued growth, but a diversification that is so overwhelming to all the other aspects of the community will not only create very few jobs, and create environmental concerns, but will destroy the opportunities for other growth as companies see Vancouver as the "Oil Port" and their families don't want to move here because of very real environmental concerns.

Respectfully, think beyond the few jobs that the oil port will create and see a future with higher paying, better for the environment and family friendly employers. The opportunities will be there if we create the environment for them.
