COMMENTS ON THE REVIUSED MDNS FOR CARRIGER SOLAR FOR THE RECORD.

- 1. Carriger solar fails to preserve the quality of Klickitat County.**
 - 2. Carriger solar was not properly sited per the law as it is too close to residential property.**
 - 3. Carriger solar was not sited in a location that does the least amount of harm to prime farmland, residential properties, wildlife, environment and viewshed.**
 - 4. The May 5, 2025 EFSEC expedited process meeting in Goldendale denied the people of their Procedural Due Process which is a civil rights violation. You made your decision and then allowed the people to comment.**
 - 5. Carriger solar is in violation of RCW 89.10**
 - 6. Carriger solar is in conflict with common agricultural practices**
 - 7. Carriger solar fails to meet KCC 19.16.010 as no BOA CUP has been issued.**
 - 8. The entire Carriger solar project is required to have a Klickitat County issued CUP and it does not**
 - 9. Carriger solar is detrimental to adjacent properties and should not be permitted**
 - 10. Carriger solar does not maintain the openness and rural character of Klickitat County countryside**
 - 11. Project was not approved by the U.S. Department of Defense**
 - 12. No CUP was granted by Klickitat County for Carriger solar power line along Knight Road**
 - 13. EFSEC required Wautoma solar facility in Benton County to have an artificial water source for helicopter dipping therefore Carriger solar must be required to have the same.**
 - 14. EFSEC has failed to protect the people of Klickitat County from the dangers associated with the BESS which fires explosions and release of deadly gases. No notification system is in place for 911 or Rural 7 fire, no alarm system for notification of nearby people, no 24/7 on-site personnel to provide notifications, no evacuation plan, no shelter for evacuated people. Carriger solar cannot be permitted until all these issues are addressed**
 - 15. EFSEC has failed to balance the benefit to the community versus the negative impacts Carriger will have on the community. RCW 80.50.101**
 - 16. Natural screening must apply to all adjacent properties not just DNR properties.**
 - 17. USDA has determined the land Carriger solar has plans to build on is prime farmland and it should not be built on this prime farmland.**
- Carriger solar is being expedited by EFSEC against the will of the people in order to have it permitted before federal funding eliminated. Carriger solar will produce little energy to support America and are here for the federal money nothing else.
