The administrative law judge will conduct a Prehearing Conference. At the Prehearing Conference, the administrative law judge will schedule the hearing and plan the hearing process. Under RCW 34.05.431 and WAC 10-08-130, a Prehearing Conference is scheduled for:

- You are not the Meeting Organizer so do NOT press the * key if asked to do so.
- You will now be placed in the hearing lobby awaiting the Judge to begin the hearing (you may hear HOLD music).
- Make sure your phone has reception and is charged to last at least an hour, and that you are in a quiet place where you can hear and be heard clearly.
- If you have problems joining the telephone conference, or if the judge does not join within ten minutes after the conference start time, immediately call the EFSEC Mainline at (360) 664-1345 or email efsec.wa.gov to request assistance.
- If you get disconnected, call back using the same phone number and access code listed in Steps 1. and 2. above.
- If you have trouble getting reconnected to the telephone conference, call (360) 664-1345 immediately for help.
- Counsel for parties, including petitioners for intervention, should join the meeting at least five minutes before 1:30 p.m. to ensure the conference can start promptly at the scheduled time.

If you are unable to call in, you may request a continuance of the Prehearing Conference. A request must include a reason. The continuance will only be granted if you can show good cause. Please send your request to the assigned administrative law judge at:

You must send a copy of your request to everyone listed on the Certificate of Service. If the request is urgent, call (253) 476-6888. You must call in unless the Office of Administrative Hearings notifies you that the Prehearing Conference is continued.

Please note that this pre-hearing conference will not include any opportunity for public comment on the proposed facility, but is solely for the attorneys for entities that will be participating as formal parties in the adjudication, including intervenors, to discuss the procedural matters described in this notice.

Please be prepared to discuss the following at the prehearing conference:

- 1. The duration you will need to present your case in chief.
- 2. Your representatives and witnesses availability for the evidentiary hearing in late-August through early October 2024.
- 3. Discovery needs.
- 4. Issues within the scope of the topic for adjudication which are ripe for stipulation to streamline the hearing.
